- Use **BLACK INK** and attach a business card if available.
- Pictures **MUST** be submitted if you are a new vendor applicant or you have not participated in the Ramstein Bazaar in the past 3 years.
- Once the applications have been reviewed by the selection committee, all decisions are **FINAL**. You will be notified by Email or mail whether you have been selected or not. You will receive further instruction and contact information at that time.
- If you have been selected as an alternate, you will be notified if a space becomes available and will be placed in slots at the selection committees' discretion.
- Applications received after **01 April 2010** will be considered on a space available basis.
- If you are a selected vendor for the 2010 Ramstein Bazaar, you will **NOT** need a police report of good conduct **IF** you possess one of the following: *USAFE-wide, KMC-wide or Ramstein only Base Installation Pass (valid through 16 September 2010) or US Military ID Card.*
- All selected vendors who do not have one of the IDs listed above will be required to obtain a police report of good conduct. **DO NOT** apply for your police report of good conduct until **AFTER** you have been accepted as a vendor for the 2010 Ramstein Bazaar. Anyone who has not completed this requirement will not be permitted access to the installation.
- Please **DO NOT** send a price list, trade license or proof of liability insurance at this time.
